SECOND AMENDMENT TO CIBOLO CANYONS RESORT MASTER COVENANT [WITHDRAWAL OF LAND]

This Second Amendment to Cibolo Canyons Resort Master Covenant (the "Amendment") is made by FORESTAR (USA) REAL ESTATE GROUP, INC., a Delaware corporation formerly known as LUMBERMEN'S INVESTMENT CORPORATION ("Declarant"), and is as follows:

RECITALS:

- A. Declarant previously executed and recorded that certain <u>Cibolo Canyons Resort Master Covenant</u>, recorded as Document No. 20050216763 in Volume 11653, Page 922 et seq. of the Official Public Records of Bexar County, Texas, as amended/affected by that certain <u>First Amendment to Cibolo Canyons Resort Master Covenant</u> made by Declarant and recorded July 10, 2006 as Instrument Number 20060161466 in Volume 12242, Page 1196 et seq. of the Official Public Records of Bexar County, Texas (collectively, the "Master Covenant").
- **B.** Section 8.03 of the Master Covenant provides that the Master Covenant may be amended by the Declarant, acting alone, by recording in the Official Public Records of Bexar County, Texas, an instrument setting forth the amendment executed and acknowledged by the Declarant.
- C. Declarant desires to remove approximately 665 acres of real property located in Bexar County, Texas, as more particularly described on <u>Attachment 1</u> attached hereto (the "Land"), from the real property described on "<u>Exhibit A</u>" to the Master Covenant.
- D. Portions of the Property (as described on "Exhibit A" to the Master Covenant) are subjected to the covenants, conditions, and restrictions set forth in the Master Covenant only upon the filing of a "Notice of Applicability" pursuant to Section 10.05 of the Master Covenant. The Land has not been made subject to the covenants, conditions, and restrictions set forth in the Master Covenant because a Notice of Applicability has not been filed with respect to the Land.

NOW THEREFORE, Declarant hereby amends and modifies the Master Covenant as follows:

1. Amendment and Partial Release of Master Covenant. The Land is hereby withdrawn from the Property which may be made subject to the terms and provisions of the Master Covenant and is hereby released and discharged from any and all covenants, conditions, restrictions, assessments, fines, liens and/or other obligations of any nature whatsoever arising or alleged to arise or to have arisen under the Master Covenant, as fully and effectively as if the Master Covenant had never been recorded against the Land.

2. Miscellaneous. Any capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Master Covenant. Unless expressly amended by this Amendment, all other terms and provisions of the Master Covenant remain in full force and effect as written, and are hereby ratified and confirmed.
